





Infrastructure:

We have two floors occupied by five rooms in area of 930 square feet with each floor. Each floor has its own name according to its work purpose. Level A, known as Administrative floor consists of five rooms and each room has spacious, well decorated and air conditioned rooms with CCTV cameras connected to view each and every activities.

Similarly, Level B, known as Academic Cum Marketing Floor also has five rooms having air conditioned classrooms with cozy environment and well equipped infrastructures. Each classroom has a multimedia system to use in teaching effectively. 


