

Statement of Purpose

To introduce myself as Nabin KC born on 4th April 1998 as a son of Kulman Khatri and Belkumari Khatri and raised in the Ghorahi-10 Dang district which is located in the Mid-West part of Nepal. Regarding my qualification, I have completed my School Leaving Certificate (SLC) from Shree Laligurans Secondary Boarding School with 67.75% where I managed to score 85% in "Computer Science". Then, I completed my higher education from Gorkha International Public Higher Secondary School with 55.90%. After year 12, I realized that science with major physics was not my subject and did a bit research reviewing my past academic performance. I came with conclusion that I was good at computer and interested in it, which made me optimistic about my career in IT.

I have researched and tested my interest through different tools and application available on the internet and also went to the fine education counsellor in the city. Through the help of the various tools and technique, I found that my interest is in Information technology. Even, I realized myself as of how interested I'm in using technology in my day to day life and always curious to know how these applications are made and how to improve it. I was interested in talking about different applications that people use in their day to day life such as mobiles apps and software technology. After completing this course, I could join Bachelor in Western Sydney University or ACU as a credit transfer student.
